KENTUCKY STATE GOVERNMENT SPENDING ON RESTRICTED TECHNOLOGY

Update

- In February 2024, China Tech Threat (CTT) accessed <u>transparency.ky.gov</u>.
- The portal reported that since CTT's last report in 2023, the state of Kentucky spent an additional \$906,379 in 2024 and \$1,805,465 in 2023 on restricted Chinese technology from Lenovo, Inc. Additional purchases of Lexmark, Inc. technology were made between 2022 and 2024.
- Factoring in the updated numbers, the state of Kentucky spent a combined \$8,488,286 on restricted technology from Lenovo, Inc. and Lexmark, Inc. between 2015 and 2024.

The Problem

Chinese government-owned technology manufacturers Lenovo and Lexmark have been
restricted from U.S. military and intelligence agencies due to their connection to the
Chinese government and military. While federal policy directs information security at the
federal level, states must determine their own security standards making states
vulnerable to intrusion through the purchase of these risky Chinese technology

The Process

- On August 15, 2022, China Tech Threat (CTT) reached out to the Kentucky Department
 of Administration requesting documents relevant to purchases of Lexmark and Lenovo
 products and services. CTT requested exact numbers, dollars spent, products and
 services purchased, and the quantity of products and services purchased. Following a
 series of subsequent emails and phone calls to advance the request with no response,
 we were able to find the vendor expenses for the years 2016 to 2022 on
 transparency.ky.gov, the state's public accountability database (see CTT's prior <u>Fact</u>
 <u>Sheet</u>, dated February 2023).
- However, purchases of restricted technology through third-party resellers, which can be significant, are not yet captured in our research. For example, in Kentucky, CDWG is identified as a <u>qualified reseller</u> by the National Association of State Procurement Officers. Any future efforts to identify and restrict purchases of Chinese-owned technology manufacturers should include resellers.
